

RESOLUTION – R-09-06

**RESOLUTION ADOPTING PAYMENT OF TAXES AND
INTEREST REQUIRED TO BE PAID ON THE DELINQUENT
TAXES BY TAXPAYERS OF THE TOWNSHIP OF SOUTH HARRISON**

WHEREAS, it is necessary that the Township Committee of the Township of South Harrison adopt a resolution relative to the payment of taxes and interest which is required to be paid on delinquent taxes by taxpayers of the Township of South Harrison,

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of South Harrison, in the County of Gloucester and State of New Jersey, that all taxes for the current year of 2009 shall be paid quarterly, without interest if payments are made on or before February 1, 2009, May 1, 2009, August 1, 2009, and November 1, 2009. All taxes for the year 2009 paid after these dates shall be subject to interest at a rate of 8% per annum, except exceeding \$1,500.00 which shall be subject to interest at a rate of 18% per annum.

BE IT FURTHER RESOLVED that no interest shall be charged if payment of any installment of taxes is made within the tenth calendar day following the date upon which the same became payable.

BE IT FURTHER RESOLVED that pursuant to N.J.S.A. 40:5-18, a service charge shall be added to any taxes owing to Municipality if payment tendered on said taxes was by a check or other written instrument which was returned for insufficient funds. Said service charge shall be \$20.00 per check or other written instrument that was returned for insufficient funds. Said service charge shall be included on whatever list of delinquent taxes is prepared for enforcement of the lien of such taxes. Any service charge for such returned check or other written instrument shall be collected in the same manner prescribed by law for the collection of

taxes for which the check or other instrument was tendered. As authorized by N.J.S.A. 40:5-19, any replacement payment of a check or other written instrument that was returned for insufficient funds must be tendered in cash or by certified check.

BE IT FURTHER RESOLVED, that in addition to the interest provided above, on all delinquencies in excess of Ten Thousand (\$10,000.00) Dollars and which are not paid prior to the end of the fiscal year, the tax collector shall also collect a penalty of six (6) percent of the amount of the delinquency in excess of Ten Thousand (\$10,000.00) Dollars.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be delivered to the Tax Collector of the Township of South Harrison, in the County of Gloucester and State of New Jersey, for compliance in accordance with this resolution.
