**RESOLUTION BY THE SOUTH HARRISON TOWNSHIP COMMITTEE
REDUCING AND CERTIFYING AMOUNT TO BE RAISED
FOR SCHOOL TAXES FOR THE 2010-2011 SCHOOL YEAR**

WHEREAS, at the annual School Election held on April 20, 2010, the voters of the Township of South Harrison rejected the amount proposed in the school budget for the South Harrison Township School District for the 2010-2011 school year; and

WHEREAS, the South Harrison Township Committee, pursuant to N.J.S.A. 18A:22-37, after consultation with the Board of Education and the South Harrison Township School District, have determined the amount of reduction, which in the judgment of the South Harrison Township Committee is necessary to be reduced for each item appearing in such budget that will provide a thorough and efficient system of schools in the district; and

WHEREAS, the South Harrison Township Committee identified certain line item reductions in the proposed Local School Board Budget, the particular details of which are identified on Exhibit A attached hereto, and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED, by the South Harrison Township Committee that it hereby certifies to the Gloucester County Board of Taxation that the total amount so determined to be necessary to be raised by taxes for the 2010-2011 school year for the South Harrison Township School District is identified and specifically referenced by Exhibit A attached hereto, and incorporated herein by reference.

BE IT FURTHER RESOLVED, that the South Harrison Township Committee does hereby certify that the Committee reviewed the revised local school budget and has determined that it is sufficient to assure the provision of a thorough and efficient system of education.

BE IT FURTHER RESOLVED, that certified copies of this resolution be forwarded to:

- A. South Harrison Township Board of Education;
- B. Gloucester County Board of Taxation;
- C. South Harrison Township Tax Assessor; and
- D. Gloucester County Superintendent of Schools (2 copies).

BE IT FURTHER RESOLVED, that the Township Clerk forward copies of this Resolution immediately upon the adoption hereof to the persons and/or departments hereinabove referenced for Certification purposes.
