

**RESOLUTION AUTHORIZING AWARD OF CONTRACT FOR THE COLLECTION AND REMOVAL OF GARBAGE, TRASH AND RECYCLABLES**

**WHEREAS**, the Township of South Harrison heretofore invited Public Bids for the collection and removal of garbage, trash and recyclable material; and

**WHEREAS**, Bids were received and publicly opened by the Borough Clerk and Township Solicitor on June 8, 2011; and;

**WHEREAS**, the three (3) Bids were received by the Township of South Harrison from the following companies: Casworth Enterprises, Inc.; Solid Waste Services, Inc. (d/b/a J. P. Mascaro & Sons); and Waste Management of New Jersey, Inc.;

**WHEREAS**, Waste Management of New Jersey, Inc. submitted the lowest responsible Bid for “Option 2” (five [5] year contract with trash hauler owning recycling commodity); and

**WHEREAS**, the Township Solicitor has reviewed and accepted the Bid Documents submitted by Waste Management of New Jersey, Inc. as conforming to the Bid Documents, Specifications and Instructions to Bidders; and

**WHEREAS**, the Township Chief Financial Officer, Christie Ehret, has certified the availability of funds for the subject Contract under Certification dated July 20, 2011, as required by N.J.S.A. 40A:4-57 and N.J.A.C. 5:30, which appropriation shall be charged to Line Item 1-01-26-305-225-Solid Waste – OE on the official Township Budget;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of South Harrison that Waste Management of New Jersey, Inc. is hereby awarded a five (5) year Contract under "Option 2" of the Bid Specifications for the collection and removal of garbage, trash and recyclable material for a total Contract sum of \$642,594.60, subject to and conditioned upon Bidder's compliance with all other terms and conditions of the Bid Documents and Bid Specifications; and

**BE IT FURTHER RESOLVED** that the Mayor and Township Clerk are hereby authorized and directed to execute the Contract in furtherance of the above and the Township Clerk is further directed to return all Bid Surety Documents to the unsuccessful Bidders named herein.
