

**RESOLUTION AWARDING CONTRACT FOR THE  
FY 2011 NJDOT TRUST FUND-PHASE II RECONSTRUCTION  
OF CEDAR GROVE ROAD IMPROVEMENT PROJECT**

**WHEREAS**, the Township of South Harrison has heretofore invited the submission of public bids for the provision of all labor, material and work required for the “FY 2011 NJDOT Trust Fund, Phase II Reconstruction of Cedar Grove Road Project”; and

**WHEREAS**, sealed bids were received and publicly opened on March 13, 2012, pursuant to the public advertisement published for the Project; and

**WHEREAS**, Gerald A. Barrett, LLC, was deemed to be the lowest responsible bidder by the Township Engineer (Project No.: SHT 2011-0B) for the combined bid proposal in the sum of Two Hundred Forty-Three Thousand One Hundred Two Dollars (\$243,102.00); and

**WHEREAS**, the bid proposal submitted by Gerald A. Barrett, LLC, in the amount of \$243,102.00 consists of the following:

Base Bid Amount -	\$196,062.70
Alternate Bid #1 Amount -	\$ 20,560.90
Alternate Bid #2 Amount -	\$ 26,478.40

**WHEREAS**, the Township Engineer has reviewed the bid proposal submitted by Gerald A. Barrett, LLC, and the documents submitted in connection therewith and has further recommended award of the bid to Gerald A. Barrett, LLC, and has otherwise determined Gerald A. Barrett, LLC, to be qualified; and

**WHEREAS**, the bid submitted by the aforesaid Gerald A. Barrett, LLC, is in substantial compliance with the bid instructions and specifications incorporated therein;

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of South Harrison, that the bid proposal submitted by Gerald A. Barrett, LLC, in a sum not to exceed \$243,102.00 is hereby accepted and Gerald A. Barrett, LLC, is hereby awarded a Contract for such sum, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by Gerald A. Barrett, LLC, including, but not limited to, NJDOT Local Aid Funding of the Cedar Grove Road Reconstruction – Phase II Project;

**BET IT FURTHER RESOLVED** that the Township Clerk is hereby authorized and directed to return all bid surety to all unsuccessful bidders forthwith after the adoption hereof.
