

**RESOLUTION AWARDING CONTRACT FOR PURCHASE  
OF A NEW 2012 DODGE CHARGER FOR THE SOUTH  
HARRISON TOWNSHIP POLICE DEPARTMENT**

**WHEREAS**, the Township of South Harrison has the need to purchase a new vehicle for use by the South Harrison Township Police Department; and

**WHEREAS**, in accordance with N.J.A.C.5:34-7.1, et seq., the Township may award a Contract without publicly advertising for bids when purchasing under any Contract entered into with the Township of Cranford under their Cooperative Pricing Agreement with Warnock Fleet and Leasing; and

**WHEREAS**, the Township of Cranford through a fair and open process, has awarded a Contract for the purchase of Police and Administrative vehicles (Cranford Police Cooperative Pricing System/Identifier 47-CPCPS) from Warnock Fleet and Leasing; and

**WHEREAS**, the Township of South Harrison desires to purchase a 2012 Dodge Charger, three (3) year Lease with purchase option (Warnock Fleet and Leasing Contract 101 Item #8), under the Cranford Cooperative Pricing Agreement for a cost not to exceed \$26,884.00 (Ford Credit Municipal Finance Quotation/Bid #72543) in accordance with the documents annexed hereto, and it is the recommendation of the Officer in Charge that the purchase of this vehicle will meet the needs of the South Harrison Township Police Department, and that it is in the Township's best interest to award a Contract to this company for said vehicle; and

**WHEREAS**, the Chief Financial Officer of the Township of South Harrison has certified, in accordance with the Certification of Funds form attached hereto, that funds are available for this purchase in the amount not to exceed \$26,884.00.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of South Harrison, that a Contract be awarded to Warnock Fleet and Leasing for the purchase of a new 2012 Dodge Charger, in accordance with the terms and conditions of the Township of Cranford Cooperative Pricing Agreement (Cranford Police Cooperative Pricing System Identifier 47-CPCPS)(Contract 101 Item #8) for a cost not to exceed \$26,884.00 (Ford Credit Municipal Finance Quotation/Bid #72543).

**BE IT FURTHER RESOLVED**, that the Mayor and Township Clerk are hereby authorized to execute any and all necessary documents pursuant to said award.
