**RESOLUTION OF THE TOWNSHIP OF SOUTH HARRISON AUTHORIZING  
BID AWARD AND CONTRACT FOR USED 2010 JOHN DEERE 310J BACKHOE**

**WHEREAS**, the Township heretofore invited public Bids for a used Backhoe for the Township of South Harrison Public Works Department; and

**WHEREAS**, sealed bids were received by the Township Solicitor and Clerk on February 12, 2013, for a used 2008 - 2011 Backhoe with Cab; and

**WHEREAS**, the Township Committee has reviewed the recommendations made by the Township Solicitor on said Bids; and

**WHEREAS**, the Chief Finance Officer has determined sufficient funds are available to purchase the equipment, as evidenced by the Chief Finance Officer's Certification filed with the Township Clerk; and

**WHEREAS**, three (3) Bid packages were received at the Bid Opening from the following vendors: Jesco; Eagle Power & Equipment; and Advantage Equipment Sales; and

**WHEREAS**, JESCO has submitted the lowest responsible Bid in conformance with the Bid Specifications and the Township Solicitor has recommended acceptance of the Proposal and Base Bid submitted.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of South Harrison, County of Gloucester and State of New Jersey, that JESCO be and is hereby awarded a Contract for the purchase of a certain 2010 John Deere 310J used backhoe (Vin No.: 1T0310JXCA0182171) for the above-referenced Base Bid Proposal, subject to and conditioned upon Bidder's compliance with all other terms and conditions of the Specifications;

**BE IT FURTHER RESOLVED**, that the Mayor and Township Clerk are hereby authorized and directed to execute the Contract for a certain 2010 John Deere 310J (Vin No.: 1T0310JXCA0182171) used Backhoe.

**BE IT FURTHER RESOLVED**, that the Township Clerk is hereby authorized and directed to return the certified checks or Bid Bonds of the following unsuccessful bidders:

1. Eagle Power & Equipment
2. Advantage Rental Center, Inc.

**BE IT FURTHER RESOLVED**, that the Clerk forward a true copy of this Resolution to JESCO, forthwith after the adoption hereof.
