

**RESOLUTION R-13-91**

**RESOLUTION ESTABLISHING EXTRA-DUTY COMPENSATION  
FOR SOUTH HARRISON TOWNSHIP OFFICERS PERFORMING  
EXTRA-DUTY SERVICES AND ASSOCIATED COSTS**

**WHEREAS,** Ordinance O-03-08 codified within Chapter 24, Article III, of the Township Code sets forth the terms and conditions under which South Harrison Township Officers may contract for extra-duty Police employment; and

**WHEREAS,** Ordinance 0-03-08 (Chapter 24 of the Township Code) requires the fees to be charged for extra-duty outside Police work to be set by Resolution.

**NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of South Harrison, that the extra-duty compensation fees charged to employers for contracting the services of South Harrison Township Officers, including, but not limited to, Administrative costs and costs associated with Police vehicles under terms set forth in Chapter 24, Article III, of the Township Code entitled "Extra-Duty Details", shall be as follows:

1. Rates for payment of Officers performing extra-duty employment for off-duty assignments until further modification by the Township of South Harrison Committee shall be the hourly sum of Seventy Dollars (\$70.00) for the first continuous eight (8) hours of service, Monday through Friday, between the hours of 0600 to 1800, and Ninety Dollars (\$90.00) after the first eight (8) hours of service (Minimum 4 hour shift). For all extra-duty service between the hours of 1801 to 0559 and between the hours of Friday midnight to Sunday midnight, at a rate of Ninety Dollars (\$90.00) an hour shall apply.
2. The Administrative Fee shall be twenty-five percent (25%) of the hourly rate rounded to Eighteen Dollars (\$18.00) per hour per Officer for each hour worked by the Officer. (Minimum 4 hours). The Administrative Fee shall be deducted and paid over to the Township Treasurer to defray the anticipated costs of Workers Compensation premiums, insurances, and clerical and administrative expenses associated with such extra-duty assignments.

3. Rate per vehicle – The hourly rate for South Harrison Township vehicles shall be Twenty-Five Dollars (\$25.00). (Minimum 4 hours per use).
