**RESOLUTION AUTHORIZING PURCHASE OF SINGLE CAMERA
MOBILE SLATE ALPR READER SYSTEM**

WHEREAS, the Township of South Harrison desires to purchase a Single Camera Mobile SLATE Automatic License Plate Reader for the South Harrison Township Police Department; and

WHEREAS, the State of New Jersey has awarded Contracts to various vendors as successful bidders for State Contracts to provide such equipment; and

WHEREAS, the Township of South Harrison is authorized by law to purchase goods or services from approved vendors who have been awarded by and have existing Contracts with the State of New Jersey (hereinafter "State"); and

WHEREAS, the ALPR System is available for purchase under State Contract #80311(GS-35F-0574X) from General Sales Administration, Inc., t/a Major Police Supply, located at 47 North Dell Avenue, Kenil, New Jersey, 07847; and

WHEREAS, funds are available for the purchase of said System, and the Township desires to specifically purchase a Single Camera Mobile SLATE ALPR Reader System, inclusive of installation and related equipment and software pursuant to State Contract #80311 in the gross amount of Twelve Thousand Six Hundred Eight Dollars and Thirty-One Cents (\$12,608.31) memorialized by the Contract Proposal dated October 9, 2013, incorporated herein by reference; and

WHEREAS, the Chief Financial Officer has certified that sufficient funding exists for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of South Harrison, as follows:

1. That the Township Committee does hereby authorize the purchase of a Single Camera Mobile SLATE ALPR Reader System in an amount not to exceed \$12,608.31 from General Sales Administration, Inc., t/a Major Police Supply, 47 North Dell Avenue, Kenil, New Jersey, 07847, an approved State Contract Vendor #G2001/80311, with a properly executed Purchase Order.

2. That the Purchase Order and/or Agreement for the purchase of the Single Camera Mobile SLATE ALPR Reader System is hereby authorized and directed subject to the review of the Chief Financial Officer/Qualified Purchasing Agent.

BE IT FURTHER RESOLVED, that a true copy of this Resolution shall be forwarded to the Chief Financial Officer; Chief of Police; Gloucester County Prosecutor's Office; Township Clerk; and any other interested parties.
