

RESOLUTION AWARDING CONTRACT FOR THE SOCCER FIELDS AND IRRIGATION SYSTEM PROJECT AT STEWART PARK

WHEREAS, the Township of South Harrison has heretofore invited the submission of public bids for the provision of all labor, material and work for the "Soccer Fields and Irrigation System Project at Stewart Park"; and

WHEREAS, a total of five (5) sealed Bids were received and publicly opened on April 29, 2014; and

WHEREAS, LANDSCAPE MAINTENANCE & NURSERY, LLC, was deemed to be the lowest responsible bidder by the Township Engineer (Project No.: SHT2013-2), as well as by the Township Solicitor, for the Base Bid Proposal in the sum of One Hundred Twenty-Five Thousand Three Hundred Six Dollars Thirty Cents (\$125,306.30); and

WHEREAS, the Base Bid Proposal submitted by LANDSCAPE MAINTENANCE & NURSERY, LLC, was in the amount of One Hundred Twenty-Five Thousand Three Hundred Six Dollars Thirty Cents (\$125,306.30); and

WHEREAS, the Township Engineer, as well as the Township Solicitor, reviewed the Bid Proposal submitted by LANDSCAPE MAINTENANCE & NURSERY, LLC, as well as the documents submitted in connection therewith, and has further recommended award of the Bid to LANDSCAPE MAINTENANCE & NURSERY, LLC, and has otherwise determined LANDSCAPE MAINTENANCE & NURSERY, LLC, to be qualified as the lowest responsible bidder; and

WHEREAS, the Bid submitted by the aforesaid LANDSCAPE MAINTENANCE & NURSERY, LLC, is in substantial compliance with the Bid Instructions and Specifications incorporated therein.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of South Harrison, that the Base Bid Proposal submitted by LANDSCAPE MAINTENANCE & NURSERY, LLC, in a sum not to exceed \$125,306.30 is hereby accepted, and LANDSCAPE MAINTENANCE & NURSERY, LLC, is hereby awarded a Contract for such sum, subject to and conditioned upon the provisions of performance surety and further compliance with the Bid documents and Specifications, which are incorporated herein by reference; and

BE IT FURTHER RESOLVED, that the Township Clerk is hereby authorized and directed to return all Bid surety to all unsuccessful bidders forthwith after the adoption hereof.
