

**RESOLUTION – R-14-63**

**RESOLUTION AWARDING CONTRACT FOR THE  
FY 2013 NJDOT TRUST FUND- RECONSTRUCTION OF  
CEDAR GROVE ROAD – PHASE III IMPROVEMENT PROJECT**

**WHEREAS**, the Township of South Harrison has heretofore invited the submission of public bids for the provision of all labor, material and work required for the “FY 2013 NJDOT Trust Fund, Reconstruction of Cedar Grove Road – Phase III Project”; and

**WHEREAS**, sealed bids were received and publicly opened on June 10, 2014 pursuant to the public advertisement published for the project; and

**WHEREAS**, a total of five (5) Contractors submitted Bids (which Bid Packages were reviewed by the Township Engineer; and

**WHEREAS**, LANDBERG CONSTRUCTION, LLC (P.O. Box 280, Mays Landing, New Jersey, 08330), was deemed to be the lowest responsible bidder by the Township Engineer for the Base Bid and Alternate Bid #1 Proposals in the sum of \$248,174.80; and

**WHEREAS**, the Township Engineer has reviewed the bid proposal submitted by LANDBERG CONSTRUCTION, LLC, and documents submitted and has further recommended award of the bid to LANDBERG CONSTRUCTION, LLC, and has otherwise determined LANDBERG CONSTRUCTION, LLC, to be qualified; and

**WHEREAS**, the bid submitted by the aforesaid LANDBERG CONSTRUCTION, LLC, is in substantial compliance with the bid instructions and specifications incorporated therein;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of South Harrison, with the Mayor concurring, that the Base Bid and Alternate Bid #1 Proposals of LANDBERG CONSTRUCTION, LLC, in a sum not to exceed \$248,174.80 is hereby accepted, and LANDBERG CONSTRUCTION, LLC, is hereby awarded a Contract for such sum, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by LANDBERG CONSTRUCTION, LLC, including, but not limited to, NJDOT Local Aid Funding of the Cedar Grove Road – Phase III Reconstruction Project.

**BE IT FURTHER RESOLVED** that the Township Clerk is hereby authorized and directed to return all Bid Surety to all unsuccessful bidders forthwith after the adoption hereof.
