

RESOLUTION – R-14-78

**RESOLUTION AWARDING CONTRACT FOR THE
FY 2014 NJDOT TRUST FUND- RECONSTRUCTION OF
LINCOLN MILL ROAD IMPROVEMENT PROJECT**

WHEREAS, the Township of South Harrison has heretofore invited the submission of public bids for the provision of all labor, material and work required for the “FY 2014 NJDOT Trust Fund, Reconstruction of Lincoln Mill Road Improvement Project”; and

WHEREAS, sealed bids were received and publicly opened on September 25, 2014, pursuant to the public advertisement published for the project; and

WHEREAS, a total of three (3) Contractors submitted Bids, which Bid Packages were reviewed by the Township Engineer; and

WHEREAS, RICHARD E. PIERSON CONSTRUCTION COMPANY, INC. (P.O. Box 430, Woodstown, New Jersey, 08098), was deemed to be the lowest responsible bidder by the Township Engineer for the Base Bid and Alternate Bid #1 Proposals in the sum of \$156,381.40; and

WHEREAS, the Township Engineer has reviewed the bid proposal submitted by RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., and documents submitted and has further recommended award of the bid to RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., and has otherwise determined RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., to be qualified; and

WHEREAS, the bid submitted by the aforesaid RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., is in substantial compliance with the bid instructions and specifications incorporated therein;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of South Harrison, with the Mayor concurring, that the Base Bid and Alternate Bid #1 Proposal of RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., in a sum not to exceed \$156,381.40 is hereby accepted, and RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., is hereby awarded a Contract for such sum, subject to and conditioned upon the provisions of performance surety and further compliance with the bid documents and specifications by RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., including, but not limited to, NJDOT Local Aid Funding of the Lincoln Mill Road Improvement Project.

BE IT FURTHER RESOLVED that the Township Clerk is hereby authorized and directed to return all Bid Surety to all unsuccessful bidders forthwith after the adoption hereof.
