

**RESOLUTION AUTHORIZING CHANGE ORDER NO. 2 AND
FINAL PAYMENT FOR THE RECONSTRUCTION OF LINCOLN MILL ROAD**

WHEREAS, the Township of South Harrison heretofore awarded the bid for the Reconstruction of Lincoln Mill Road to RICHARD E. PIERSON CONSTRUCTION COMPANY, INC., under the Fiscal Year 2014 NJDOT Trust Fund; and

WHEREAS, the Township requested certain revisions to the Specifications of the Project resulting in a decrease in the Project costs in the sum of \$18,430.06, such decrease reflected in Change Order No. 2 attached hereto and made a part hereof; and

WHEREAS, the Contractor has also requested final payment and release of the retainage for the Project, including the deduction reflected in Change Order No. 2 in the amount of \$18,430.06; and

WHEREAS, the Township Engineer has inspected the work completed and recommended authorization of the aforesaid Change Order No. 2 and final payment by way of release of the retainage in the amount of \$10,640.24 to Richard E. Pierson Construction Company, Inc. subject, however, to the conditions and recommendations made by the Township Engineer memorialized by correspondence dated August 3, 2015.

NOW THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of South Harrison, that the aforesaid Change Order No. 2 in the amount of \$18,430.06 and release of the retainage in the amount of \$10,640.24 is hereby approved and authorized by the Township Committee subject, however, to the conditions memorialized within the Township Engineer's correspondence dated August 3, 2015 incorporated herein by reference.





1. Submit a two year maintenance bond for the time period beginning 07/02/15 for 100% of the Final Contract Value of \$139,924.15 in accordance with Project Specifications Information for Bidders section 3.02.
2. Submit a signed and notarized copy of the attached Prevailing Wage Payment Certification per GC-18 of the contract documents.
3. Submit a signed and notarized copy of the attached Lien form per section 7.07 shown on page GC-7 of the contract documents.
4. Sign and return all four (4) copies of the enclosed Change Order #2 (Final). Upon execution by the Township and NJDOT Local Aid, we will return one copy to you for your files.
