

**RESOLUTION OF THE TOWNSHIP OF SOUTH HARRISON AWARDING CONTRACT FOR THE RECONSTRUCTION OF LINCOLN MILL ROAD-PHASE II AND CEDAR GROVE ROAD-PHASE IV PROJECT PURSUANT TO NJSA 40A:11-5(3)**

**WHEREAS**, the Township of South Harrison, on two (2) separate occasions, advertised for the submission of bids relative to the Reconstruction of Lincoln Mill Road-Phase II and Cedar Grove Road-Phase IV Road Project; and

**WHEREAS**, bids for this road project were advertised pursuant to Section 4 of P.L. 1971, c.198 (C) 40A:11-4, on (2) separate occasions, and the Township Committee has rejected such bids because they have determined that the two (2) bids received were not reasonable as to price as such bids exceeded the cost estimate established for this project; and

**WHEREAS**, Resolution R-15-74 authorized the Township Engineer to negotiate with each responsible bidder pursuant to N.J.S.A. 40A:11-5(3); and

**WHEREAS**, the Township Engineer received one (1) negotiated bid proposal from Landberg Construction, LLC on October 21, 2015 reflecting the negotiated base bid sum of \$150,525.00; and

**WHEREAS**, The Township Engineer has recommended the award of the negotiated contract to Landberg Construction, LLC pursuant to N.J.S.A. 40A:11-5(3); and

**WHEREAS**, funds are available to defray the costs of this project as proposed;

**NOW THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of South Harrison, as follows:

1. The negotiated contract, pursuant to N.J.S.A. 40A:11-5(3), is hereby awarded to Landberg Construction, LLC in the base bid sum of \$150,525.00; and
2. The contract was negotiated in accordance with N.J.S.A. 40A:11-5(3) and adopted by a resolution of no less than a two-thirds affirmative vote of the Township Committee authorizing such contract; and
3. The Township Clerk shall provide a true copy of this Resolution to the Township Engineer, Solicitor, Chief Financial Officer and to all bidders.
