

**RESOLUTION AUTHORIZING AGREEMENTS WITH THE COUNTY OF GLOUCESTER FOR THE PROVISION OF PUBLIC SAFETY RADIO COMMUNICATIONS EQUIPMENT**

**WHEREAS**, the County of Gloucester heretofore entered into an agreement with the Motorola Corporation to design, build and implement a countywide 700 Mhz radio system to service the needs of the County, as well as the municipalities within the County of Gloucester; and

**WHEREAS**, the contract required the Motorola Corporation to supply in excess of 3,000 radios to the County as an initiative that would protect the first responders servicing the needs of the residence in the County of Gloucester and the surrounding communities; and

**WHEREAS**, the County will provide and transfer ownership of certain public safety radio communications equipment (mobile, portable and control station radios) to the various accepting municipal fire departments, fire districts, fire companies and emergency medical services agencies for use with the new 700 Mhz radio system; and

**WHEREAS**, the County of Gloucester and South Harrison Township, as well as the South Harrison Township Police Department, are required to enter into an agreement in order to ensure an appropriate and optimum use of equipment and to set forth the rights, duties and obligations between the parties hereto; and

**WHEREAS**, it is deemed to be in the best interest of the residents of the Township of South Harrison to enter into the attached agreements with the County of Gloucester.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of South Harrison, as follows:

1. The Mayor and Township Clerk are hereby authorized to execute and directed to enter into the agreement with the County of Gloucester, a copy of which is attached hereto and made a part hereof on the terms and conditions contained herein, as well as the attached agreement between the County of Gloucester and the Township of South Harrison Police Department.
2. The Mayor and Township Clerk are hereby authorized and directed to execute said agreements forthwith after the adoption hereof.
3. The Clerk of the Township of South Harrison is hereby authorized and directed to forthwith file a certified copy of this Resolution and an executed copy of the agreements with the Gloucester County Department of Emergency Response. Said
