2008 Municipal Budget

Christie Melfi advised that the Township needs \$41,800 in revenue to balance the 2008 budget. Discussion regarding the salaries in the police department being done on the anniversary date instead of January 1, this will be looked into. The executive salary line should be adjusted to remove the Mayor and Deputy Mayor salaries and \$1,000.00 put in line item for the Ethics Board and the remainder moved to the executive operating expenses. Deputy Mayor Campbell and Committeeman Spinner will meet with Colleen Bianco Thursday morning to further discuss salaries and personnel.

Open Meeting to the Public:

Motion to open the meeting to the public was made by Robert Campbell, second by Gary Spinner. Motion carried.

Mr. Nagtegaal asked if there are figures for the Master Plan for 2008. Ms. Melfi advised that is being done by special emergency appropriation to be raised over 5 years, the amount is \$5,000.00. Mr. Nagtegaal asked if the Township can recoup any of the costs associated with Perks Reutter. Deputy Mayor Campbell previously asked Mr. Eastlack that question and was told it would be a tough case and too costly. Mr. Nagtegaal asked about the list of basins he gave out stating the majority are owned by the homeowner, and he wants the Code Official to cite the people who are not maintaining their basins.
