

**AN ORDINANCE APPROPRIATING THE SUM OF \$3,200.00 FROM THE CAPITAL IMPROVEMENT FUND FOR THE PURCHASE OF A 7' GRADER BOX, 7' LANDSCAPE RAKE AND A FUEL TRANSFER TANK/TOOL BOX FOR THE F350 FOR THE PUBLIC WORKS DEPARTMENT**

**BE IT ORDAINED** and enacted by the Township Committee of the Township of South Harrison in the County of Gloucester and State of New Jersey as follows;

**SECTION 1:** The sum of Three thousand two hundred and 00/100 Dollars (\$3,200.00) is hereby appropriated for the purchase of a 7' grade box, 7' landscape rake and a fuel transfer tank/tool box for the F350 for the Public Works Department

**SECTION 2:** In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

A. The purpose described in Section 1 is not a current expense item and is an improvement which the Township of South Harrison may lawfully make as a capital improvement.

B. The period of usefulness of the items described in Section 1 hereof are outside the limitations of said Local Bond Law and the reasonable life thereof is at least five (5) years.

**SECTION 3:** All Ordinances or parts of Ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

**SECTION 4:** This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
