

**AN ORDINANCE APPROPRIATING THE SUM OF \$2,200.00
FROM THE CAPITAL IMPROVEMENT FUND FOR THE PURCHASE OF
DIGITAL RECORDING EQUIPMENT, HARDWARE AND SOFTWARE FOR
THE TOWNSHIP OF SOUTH HARRISON COUNCIL ROOM, MUNICIPAL
CLERK AND PLANNING/ZONING BOARD CLERK/SECRETARY**

BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison in the County of Gloucester and State of New Jersey as follows;

SECTION 1: The sum of Two thousand two hundred and 00/100 Dollars (\$2,200.00) is hereby appropriated for the purchase of digital recording equipment, hardware and software for the Council Room, Municipal Clerk and Planning/Zoning Board Clerk/Secretary

SECTION 2: In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

A. The purpose described in Section 1 is not a current expense item and is an improvement which the Township of South Harrison may lawfully make as a capital improvement.

B. The period of usefulness of the items described in Section 1 hereof are outside the limitations of said Local Bond Law and the reasonable life thereof is at least five (5) years.

SECTION 3: All Ordinances or parts of Ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
