

**AN ORDINANCE APPROPRIATING THE SUM OF \$1,685.00
FROM THE CAPITAL IMPROVEMENT FUND FOR THE PURCHASE
OF A (1) COLT RIFLE MODEL LE6920, (1) EOTECH HOLOGRAPHIC
RIFLE SIGHT AND (1) SUREFIRE FOREND WEAPONLIGHT FOR
THE POLICE DEPARTMENT**

BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison in the County of Gloucester and State of New Jersey as follows;

SECTION 1: The sum of One thousand six hundred eighty-five dollars (\$1,685.00) is hereby appropriated for the purchase of (1) Colt Rifle Model LE6920 under State Contract A67872, (1) EOTECH Holographic Rifle Sight and (1) Surefire Forend Weaponlight under State Contract A67872 for the Police Department

SECTION 2: In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

A. The purpose described in Section 1 is not a current expense item and is an improvement which the Township of South Harrison may lawfully make as a capital improvement.

B. The period of usefulness of the items described in Section 1 hereof are outside the limitations of said Local Bond Law and the reasonable life thereof is at least five (5) years.

SECTION 3: All Ordinances or parts of Ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
