

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON AMENDING
CHAPTER 55, CONSTRUCTION CODES, UNIFORM, PROVIDING FOR
ADMINISTRATIVE FEES TO BE COLLECTED IN CONNECTION WITH THE
ISSUANCE OF CONSTRUCTION AND RELATED PERMITS**

WHEREAS, the fees to be collected in connection with the issuance of construction and related permits are established pursuant to the New Jersey Administrative Code; and

WHEREAS, the South Harrison Township Committee has determined a need to amend Chapter 55 of the South Harrison Township Code to reflect the fees currently required pursuant to the New Jersey Administrative Code; and

WHEREAS, the South Harrison Township Committee, in order to properly administer the Township Construction Office, and in order to reflect the costs associated with application review, scheduling of inspections, receipt of applications, issuance of permits, and for staffing to attend to the administrative needs of the Township, and administrative fee as part of the fees for the permitting process is required.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of South Harrison, County of Gloucester, State of New Jersey that Chapter 55 of the South Harrison Township Code is hereby amended as follows:

§ 55-10. Administrative Surcharge

An administrative surcharge in the amount of 25% of the total permit fee required by this Chapter, shall be collected in addition to any and all other applicable fees for building subcode, plumbing subcode, electrical subcode and other permit fees. Said administrative fee shall be set forth on the permit issued together with the applicable permit fees.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect immediately upon its final passage, adoption and publication as provided by law.
