

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON
APPOINTING TAX COLLECTOR TO FILL UNEXPIRED TERM
PURSUANT TO N.J.S.A. 40A:9-142**

WHEREAS, the South Harrison Township Tax Collector, Maria Berkett, tendered her resignation to the Mayor and Township Committee that is to be effective April 30, 2010 for the Office of Tax Collector and Tax Search Officer; and

WHEREAS, N.J.S.A. 40A:9-141 provides that the appointment of the Tax Collector shall be by Ordinance and that the appointment shall be for the unexpired term of the resigning Tax Collector pursuant to N.J.S.A. 40A:9-142.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of South Harrison, that Lisa Garrison is hereby confirmed in her appointment to the position of Township Tax Search Officer and to the Office of Township Tax Collector for the unexpired term of Maria Berkett ending December 31, 2011;

BE IT FURTHER ORDAINED, as follows:

A. Compensation. Effective May 1, 2010, the annual compensation for the Township Tax Collector shall be the sum of \$9,000.00 based upon the hours of operation and work hours the Township Committee may establish from time to time for the South Harrison Township Tax Collector's Office.

B. Effective. The appointments recited herein shall take effect May 1, 2010 and this Ordinance shall take effect upon final adoption, publication and as otherwise provided by law;

C. Repealer. All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistencies;

D. Saved from Repeal. All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.
