

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE
OF THE TOWNSHIP OF SOUTH HARRISON REPEALING ARTICLE III OF
CHAPTER 19 OF THE SOUTH HARRISON TOWNSHIP CODE
ENTITLED “TOWNSHIP ADMINISTRATOR”**

WHEREAS, Ordinance O-98-03 was adopted by the Township Committee on or about March 11, 1998, and thereafter codified within Chapter 19, Article III of the South Harrison Township Code entitled “Township Administrator”; and

WHEREAS, the Mayor and Township Committee have found and determined that it is their intent to amend and repeal this Section of the Township Code to eliminate the office and position of Township Administrator as heretofore established by Sections §19-6 through §19-10 of the Code;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of South Harrison, with the Mayor concurring, as follows:

SECTION I – PURPOSE.

The purpose of this Ordinance is to amend the South Harrison Township Code and to specifically repeal Ordinance O-98-03 codified within Chapter 19, Article III, Sections §19-6 through §19-10, together with all amendments and supplements thereto.

SECTION II – REPEALED SECTIONS.

Sections §19-6 through §19-10 of the South Harrison Township Code are hereby repealed.

SECTION III – EFFECTIVE DATE.

This Ordinance shall take effect upon final adoption, publication and as otherwise provided by law.

SECTION IV – REPEALER.

All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION V – SAVED FROM REPEAL.

All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.
