

ORDINANCE – O-11-15

**AN ORDINANCE APPROPRIATING THE SUM OF \$25,000.00
FROM THE CAPITAL IMPROVEMENT FUND FOR THE
REPAIR OF THE OUTFLOW ON OLDMANS CREEK ROAD, INLETS IN
WINDY WAY, MULLICA CROSSINGS AND OVERLAY OF LAKE STREET
CAUSED BY STORM DAMAGE AND IN CONJUNCTION WITH FEMA FUNDS
BEING MADE AVAILABLE**

BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison in the County of Gloucester and State of New Jersey as follows;

SECTION 1: The sum of Twenty-five thousand dollars (\$25,000.00) is hereby appropriated from the South Harrison Township Capital Improvement Fund for use in conjunction with FEMA funds for the repair of the Outflow on Oldmans Creek Road, Inlets in Windy Way and Mullica Crossings and overlay of Lake Street caused by storm damage.

SECTION 2: In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

A. The purpose described in Section 1 is not a current expense item and is an improvement which the Township of South Harrison may lawfully make as a capital improvement.

B. The period of usefulness of the items described in Section 1 hereof are outside the limitations of said Local Bond Law and the reasonable like thereof is at least five (5) years.

SECTION 3: All Ordinances or parts of Ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
