

**ORDINANCE O-12-01**

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON  
APPOINTING TAX COLLECTOR PURSUANT TO N.J.S.A. 40A:9-142**

**WHEREAS**, the unexpired term of the Tax Collector expired December 31, 2011; and

**WHEREAS**, N.J.S.A. 40A:9-141 provides that the Township Committee, by Ordinances shall provide for the appointment of Municipal Tax Collector, which term shall be for a period of four (4) years pursuant to N.J.S.A. 40A:9-142.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Township Committee of the Township of South Harrison, County of Gloucester and State of New Jersey, that SHERI GARTON is hereby confirmed in her appointment to the position of Township Tax Search Officer and to the Office of Township Tax Collector for a term of four (4) years commencing January 1, 2012, through December 31, 2015; and

**BE IT FURTHER ORDAINED**, as follows:

- A. Compensation.** Effective January 1, 2012, the annual compensation for the Township Tax Collector shall be the sum of Nine Thousand Dollars (\$9,000.00) based upon the hours of operation and work hours the Township Committee may establish from time to time for the South Harrison Township Tax Collector's office.
- B. Effective.** The appointments recited herein shall take effect January 1, 2012, and this Ordinance shall take effect upon final adoption, publication, and as otherwise provided by law.
- C. Repealer.** All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- D. Saved from Repeal.** All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.
