

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON,
GLOUCESTER COUNTY, NEW JERSEY, APPROPRIATING THE SUM OF
FOUR THOUSAND SEVEN HUNDRED ONE DOLLARS and SEVENTY-FIVE
CENTS (\$4,701.75) FOR HVAC IMPROVEMENTS TO THE TOWNSHIP
MUNICIPAL BUILDING AND PUBLIC WORKS GARAGE**

WHEREAS, the Township of South Harrison was previously approved to participate in the New Jersey Energy Efficiency and Conservation Block Grant Rebate Program administered as an initiative by the New Jersey Board of Public Utilities; and

WHEREAS, the project consisted of HVAC improvements to the Township Municipal Building and Public Works Garage; and

WHEREAS, the project was recognized as a Direct Install Program assigned Application No.: CRG004 and CRG0016 under Account No.: 10759419997; and

WHEREAS, there remains a balance payable to Carrier Commercial Service in the amount of FOUR THOUSAND SEVEN HUNDRED ONE DOLLARS and SEVENTY-FIVE CENTS (\$4,701.75); and

WHEREAS, sufficient funds are available for said purpose from the Township's Capital Improvement Fund.

NOW, THEREFORE, BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison, County of Gloucester and State of New Jersey, that:

SECTION ONE: The funding for the Township's obligation under the Direct Install Project for HVAC improvements to the Township Municipal Building and Public Works Garage is hereby authorized in the amount of FOUR THOUSAND SEVEN HUNDRED ONE DOLLARS and SEVENTY-FIVE CENTS (\$4,701.75), which sum is hereby appropriated for such purposes.

SECTION TWO: The total amount of FOUR THOUSAND SEVEN HUNDRED ONE DOLLARS and SEVENTY-FIVE CENTS (\$4,701.75) is hereby appropriated from the Capital Improvement Fund.

SECTION THREE: No debt is authorized by this Ordinance and the Capital Budget of the Township is hereby amended.

SECTION FOUR: All Ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION FIVE: This Ordinance shall take effect immediately upon proper passage, publication in accordance with the law and after final adoption as provided by law.
