

ORDINANCE O-12-10

**ORDINANCE AUTHORIZING THE TOWNSHIP OF
SOUTH HARRISON TO EXPEND A PORTION OF THE
FUNDS MAINTAINED BY THE TOWNSHIP IN THE
PARKLAND TRUST FUND**

WHEREAS, the Township Committee of the Township of South Harrison, County of Gloucester and State of New Jersey maintains a dedicated Trust Fund for the deposit of funds received by the Township to enlargement or improvement of the South Harrison Township Park System; and

WHEREAS, the Township Code §21-2 indicates that expenditures shall be authorized to be made for improvements to South Harrison Township parklands; and

WHEREAS, the Township Committee desires to make certain improvements to the Soccer Fields within Stewart Memorial Park.

NOW, THEREFORE, BE IT ORDAINED by the Township of South Harrison, County of Gloucester, State of New Jersey, that the Township's Chief Financial Officer is authorized to expend a portion of the funds within the South Harrison Township Parkland Trust Fund in amounts not to exceed the amount set forth: Stewart Park Phase II Soccer Field Project Improvements for the purchase of construction materials and labor - \$17,499.00.

BE IT FURTHER ORDAINED that in connection with the \$17,499.00 authorized herein, the Township makes the following determinations:

A. The improvements described above are not a current expense item and are improvements which the Township of South Harrison may lawfully make as parkland improvements under §21-2 of the Township Code.

B. The period of usefulness of the improvements described herein is at least five (5) year as required by §21-2 and specifically N.J.S.A.40A:2-22.

BE IT FURTHER ORDAINED, that if any section, sentence, clause, provision or portion of this Ordinance shall be held invalid or unconstitutional by

any Court of competent jurisdiction that such holding shall not affect or impair any other section, sentence, clause, provision or portion of this Ordinance.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon its final passage, adoption, and publication as provided by law.
