

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON  
APPOINTING TAX COLLECTOR TO FILL UNEXPIRED TERM  
PURSUANT TO N.J.S.A. 40A:9-142**

**WHEREAS**, the South Harrison Township Tax Collector, LISA GARRISON, tendered her resignation to the Mayor and Township Committee that is to be effective January 13, 2013 for the Office of Tax Collector and Tax Search Officer; and

**WHEREAS**, N.J.S.A. 40A:9-141 provides that the appointment of the Tax Collector shall be by Ordinance and that the appointment shall be for the unexpired term of the resigning Tax Collector pursuant to N.J.S.A. 40A:9-142.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of South Harrison, that MICHELLE BARNABIE is hereby confirmed in her appointment to the position of Township Tax Search Officer and to the Office of Township Tax Collector for the unexpired term of LISA GARRISON ending **December 31, 2015**;

**BE IT FURTHER ORDAINED**, as follows:

- A. Compensation.** The Tax Collector's compensation for calendar year 2013 shall be consistent with the Township Salary Ordinance.
- B. Effective.** The appointments recited herein shall take retroactive effect as of January 13, 2013, and this Ordinance shall take effect upon final adoption, publication and as otherwise provided by law;
- C. Repealer.** All Ordinances or parts of Ordinances inconsistent with the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistencies;
- D. Saved From Repeal.** All Ordinances or parts of Ordinances not inconsistent with the terms and provisions of this Ordinance are hereby saved from repeal.


