

ORDINANCE O-13-06

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON,
GLOUCESTER COUNTY, NEW JERSEY, APPROPRIATING THE
SUM OF SEVEN THOUSAND DOLLARS (\$7,000.00) FROM THE CAPITAL
IMPROVEMENT FUND FOR THE INSTALLATION AND PURCHASE
OF COMPUTERS AND COMPUTER SOFTWARE**

WHEREAS, the Mayor and Township Committee of the Township of South Harrison has determined that the South Harrison Township Police Department is in need of certain computer equipment and software; and

WHEREAS, sufficient funds are available for said purpose from the Township's Capital Improvement Fund.

NOW, THEREFORE, BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison, County of Gloucester and State of New Jersey, that:

SECTION ONE: The sum of **SEVEN THOUSAND DOLLARS (\$7,000.00)** is hereby appropriated from the South Harrison Township Capital Improvement Fund for use in connection with the installation and purchase of computers and computer software for use by the South Harrison Township Police Department, which sum is hereby appropriated for such purposes.

SECTION TWO: The sum of **SEVEN THOUSAND DOLLARS (\$7,000.00)** is hereby appropriated from the Capital Improvement Fund.

SECTION THREE: No debt is authorized by this Ordinance and the Capital Budget of the Township is hereby amended.

SECTION FOUR: All Ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION FIVE: This Ordinance shall take effect immediately upon proper passage, publication in accordance with the law, and after final adoption as provided by law.
