

ORDINANCE O-13-09

AN ORDINANCE AUTHORIZING THE APPROPRIATION OF ONE HUNDRED SEVENTY-FIVE THOUSAND DOLLARS (\$175,000.00) FROM THE PARKLAND TRUST FUND FOR ATHLETIC FIELD IMPROVEMENTS WITHIN THE STEWART MEMORIAL PARK

WHEREAS, the Township of South Harrison maintains a dedicated Parkland Trust Fund codified within Section §21 of the Township Code; and

WHEREAS, Section §21-2 of the Township Code provides that expenditures from such Fund shall be authorized and limited solely to the purchase of additional South Harrison Township Parkland, or improvements to South Harrison Township Parkland; and

WHEREAS, the Township Committee desires to make certain improvements to the Athletic Fields within Stewart Memorial Park.

NOW, THEREFORE, BE IT ORDAINED by the Township of South Harrison, County of Gloucester, State of New Jersey, that the Township's Chief Financial Officer is authorized to expend a portion of the funds within the South Harrison Township Parkland Trust Fund in amounts not to exceed the amount set forth: Stewart Park Athletic Field Improvement Project for the purchase of construction materials and labor - \$175,000.00.

BE IT FURTHER ORDAINED that in connection with the \$175,000.00 dollars authorized herein, the Township makes the following determinations:

A. The improvements described above are not a current expense item and are improvements which the Township of South Harrison may lawfully make as parkland improvements under §21-2 of the Township Code.

B. The period of usefulness of the improvements described herein is at least five (5) year as required by §21-2 and specifically N.J.S.A.40A:2-22.

BE IT FURTHER ORDAINED, that if any section, sentence, clause, provision or portion of this Ordinance shall be held invalid or unconstitutional by any Court of competent jurisdiction that such holding shall not affect or impair any other section, sentence, clause, provision or portion of this Ordinance.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon its final passage, adoption, and publication as provided by law.
