

ORDINANCE 0-13-13

**AN ORDINANCE APPROPRIATING THE SUM OF \$27,100.00
FROM THE CAPITAL IMPROVEMENT FUND FOR THE
CEDAR GROVE ROAD – PHASE III PROJECT**

BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison in the County of Gloucester and State of New Jersey, as follows:

SECTION 1: The sum of Twenty Seven Thousand One Hundred Dollars (\$27,100.00) is hereby appropriated from the South Harrison Township Capital Improvement Fund for use in conjunction with the CEDAR GROVE ROAD – PHASE III IMPROVEMENT PROJECT. Together with the State DOT Grant of Three Hundred Thousand Dollars (\$300,000.00), total committed funds of Three Hundred Twenty-Seven Thousand One Hundred Dollars (\$327,100.00) is hereby committed for completion of PHASE III of the CEDAR GROVE ROAD IMPROVEMENT PROJECT.

SECTION 2: In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

- A. The purpose described in Section 1 is not a current expense item and is an improvement which the Township of South Harrison may lawfully make as a capital improvement.
- B. The period of usefulness of the items described in Section 1 hereof are outside the limitations of said Local Bond Law and the reasonable like thereof is at least five (5) years.

SECTION 3: All Ordinances or parts of Ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
