

**AN ORDINANCE APPROPRIATING THE SUM OF \$10,108.31 FROM THE CAPITAL IMPROVEMENT FUND FOR THE PURCHASE OF AN AUTOMATIC LICENSE PLATE READER, NEW JERSEY STATE CONTRACT #80311, FOR THE SOUTH HARRISON TOWNSHIP POLICE DEPARTMENT**

**BE IT ORDAINED** and enacted by the Township Committee of the Township of South Harrison in the County of Gloucester and State of New Jersey as follows;

**SECTION 1:** The sum of ten thousand one hundred eight and 31/100 Dollars (\$10,108.31) is hereby appropriated for the purchase of an Automatic License Plate Reader from General Sales Administration t/a Major Police Supply, 47 N. Dell Avenue, Kenil, NJ 07847, under state contract #80311

**SECTION 2:** In connection with the amount authorized in Section 1 hereof, the Township makes the following determinations:

A. The purpose described in Section 1 is not a current expense item and is an improvement which the Township of South Harrison may lawfully make as a capital improvement.

B. The period of usefulness of the items described in Section 1 hereof are outside the limitations of said Local Bond Law and the reasonable life thereof is at least five (5) years.

**SECTION 3:** All Ordinances or parts of Ordinances which are inconsistent with the terms of this Ordinance and the same are hereby repealed to the extent of their inconsistency.

**SECTION 4:** This Ordinance shall take effect immediately after final passage, approval and publication as provided by law.
