

ORDINANCE 0-14-11

**AN ORDINANCE OF THE TOWNSHIP OF SOUTH HARRISON,
GLOUCESTER COUNTY, NEW JERSEY, APPROPRIATING THE
SUM OF EIGHT THOUSAND DOLLARS (\$8,000.00) FOR
THE PURCHASE OF A USED DUMP TRUCK BODY BED FOR THE
TOWNSHIP PUBLIC WORKS DEPARTMENT**

WHEREAS, the Mayor and Township Committee of the Township of South Harrison has determined that the Township Public Works Department is in need of certain equipment, namely a used Dump Truck Body Bed to be utilized with the Township's Dump Truck; and

WHEREAS, sufficient funds are available for said purpose from the Township's Capital Improvement Fund.

NOW, THEREFORE, BE IT ORDAINED and enacted by the Township Committee of the Township of South Harrison, County of Gloucester and State of New Jersey, that:

SECTION ONE: The sum of EIGHT THOUSAND DOLLARS (\$8,000.00) is hereby appropriated from the South Harrison Township Capital Improvement Fund for use in conjunction with the purchase of a used Dump Truck Body Bed to be utilized with the Township's Dump Truck for the Township of South Harrison Public Works Department, which sum is hereby appropriated for such purposes.

SECTION TWO: The sum of EIGHT THOUSAND DOLLARS (\$8,000.00) is hereby appropriated from the Capital Improvement Fund.

SECTION THREE: No debt is authorized by this Ordinance and the Capital Budget of the Township is hereby amended.

SECTION FOUR: All Ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION FIVE: This Ordinance shall take effect immediately upon proper passage, publication in accordance with the law, and after final adoption as provided by law.
