

AN ORDINANCE APPROPRIATING THE SUM OF \$196,000 TO BE USED FOR THE RECONSTRUCTION OF LINCOLN MILL ROAD-PHASE I WITHIN THE TOWNSHIP OF SOUTH HARRISON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Township Committee of the Township of South Harrison desires to authorize improvements to Lincoln Mill Road within the Township of South Harrison; and

WHEREAS, sufficient funds are available for said purpose from a certain New Jersey Department of Transportation Grant and the Township's Capital Improvements Fund.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of South Harrison, County of Gloucester, and State of New Jersey, as follows:

SECTION 1: There is hereby appropriated from the following sources the sum of \$196,000.00 to be used for the following capital project within the Township of South Harrison:

Reconstruction of Lincoln Mill Road-Phase I	\$196,000	\$16,000	\$180,000	10 years

SECTION 2: In connection with the amounts authorized in Section 1, the Township makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Township may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this Ordinance.
- d) The capital budget of the Township is hereby amended.

SECTION 3: All Ordinances or parts of Ordinances that are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This Ordinance shall take effect immediately upon proper passage and publication in accordance with the law and after final adoption as provided by the law.

THE FOREGOING Ordinance was introduced by the Township Committee of the Township of South Harrison at the regular meeting held on September 10, 2014. This Ordinance will be considered for final adoption, and publication on October 8, 2014, at 7:30 p.m., or at such time as may be determined and announced, in the Office of the Township Clerk, 664 Harrisonville Road, Harrisonville, New Jersey, 08039, at which time and place all persons interested will be given an opportunity to be heard concerning said Ordinance. During the time prior to and up to and including the date of such meeting, copies of said Ordinance will be made available at the Office of the Township Clerk to the members of the general public who may request same.
