

**South Harrison Township
Planning/Zoning Board of Adjustment
January 26, 2009**

The South Harrison Township Planning/Zoning Board of Adjustment held a regular meeting on January 26, 2009 at 7:00 p.m. in the South Harrison Township Municipal Building.

Old Business:

Open Space Plan – DVRFC

Suzanne McCarthy and Kelly Rossiter of the DVRFC appeared before the Board to advise as to the progress being made with the Open Space Plan which is to be incorporated as an element of the Master Plan. Ms. McCarthy reviewed the plan Greenways Tables located within the report. The tables will be altered slightly to group all residential properties under 5 acres at the end of each Greenways Table. The tables will also include a column titled "Notes".

Ms. Rossiter reviewed Section 5 – "Active Recreation", the Board recommended adding another soccer field under the Needed section of the *Active Recreation Lands Assessment – Current and Needed Facilities*. Ms. Rossiter will contact South Harrison Elementary Superintendent to verify the school playgrounds availability to the public.

Leah Furey will contact Gary Thompson regarding language contained within Objective 4.2.1 located in Section 3 – "Municipal, County, Regional, and State Plan Consistency".

Gloucester County Habitat for Humanity (GCHFH)

Allan Connors of Gloucester County Habitat for Humanity (GCHFH) appeared before the Board to advise of the possible COAH benefits of utilizing GCHFH. Mr. Connors stated that all he would need from the Township would be a location(s) donated and that the GCHFH would be responsible for all of the building as well as the administrative requirements when dealing with COAH. Leah Furey stated that she would be in contact with Mr. Connors after talking with some possible land owners/developers.
